CALL FOR CONTRIBUTIONS IN EDITED BOOK

The Faculty of Social and Human Sciences of the Central University of Ecuador (UCE) and FILOSÓFICA, Fundación for Philosophical, Political and Cultural Studies, invite the academic community to submit proposals for chapters for an edited book that will address the philosophical thought of Edmund Husserl.

The open character of Edmund Husserl's Phenomenology, its demand that phenomenologist renounce the ideal of constructing a philosophy of their own and abide to the modest but rigorous task of describing what is given, explains, to a large extent, why phenomenology is not regarded as a school, but rather as a style or a movement marked not so much by orthodoxy as by the heresy of those who have continued, critically adopted, reconfigured and extended the movement beyond its original impulse.

The present book on Husserl's thought proposes to go back to the very source of Phenomenology in order to exhibit, though naturally not exhaustively, the scope of the subjects with which the initiator of the phenomenological movement has engaged. The aim is to reveal, if not its systematic character, at least the unitary conception underlying the analysis of the manifold dimensions of consciousness. In consonance with the division of the last volume of *Husserliana* published to date, entitled "Studies on the Structure of Consciousness" (Hua XLIII), the present book intends to offer the reader different ways of access to Husserl's thought, according to three thematic axes: firstly, the sphere of knowledge; secondly, the sphere of feeling and value; thirdly, the sphere of will and action. In addition to providing an account of the current state of the discussions surrounding Husserlian Phenomenology, this call for chapters aims to show how, more than twelve decades after its appearance, Husserl's work continues to be a source of inspiration, motivation and drive for the phenomenological movement in general, both within and outside Europe, and especially in the Americas.

SCOPE

The book will be edited and compiled by Professor/researcher *Azul Katz* of the University of Buenos Aires. It will be published in the COLECCIÓN FILOSÓFICA ACTUAL with the logo of the UCE University Press, Faculty of Social and Human Sciences.

This call is open to scholars associated with the disciplines of Political Science, Philosophy, Sociology, Anthropology, History and other fields of the Social and Human Sciences. Individual and co-authored proposals will be accepted.



STRUCTURE OF THE BOOK

In accordance with the purpose of highlighting the unitary conception that underlies the analysis of the theoretical, practical and affective dimensions of consciousness, the book is divided into three main sections. The first section is concerned with questions on the phenomenological method and the theory of knowledge. A second section is concerned with questions on value and affective consciousness. And a third section deals with questions on will and action.

MAIN THEMES AND LINES OF RESEARCH

1. Unity of consciousness and its sides
2. Theory of knowledge
3. Analysis of intentional experiences
4. Objectifying and non-objectifying consciousness
5. Consciousness of value
6. Aesthetic experience and valuation
7. Will and action
8. Ethics, politics and community

METHODOLOGICAL SCOPE

The topics of the chapters are not limited to those proposed in the previous point, but they must be framed within the general narrative. We welcome any theoretical perspective relevant for the topic in question. It is possible to propose chapters framed within the phenomenological method in general, descriptive, transcendental, static, genetic or even generative. It is suggested to begin each chapter with a brief justification of the theoretical or methodological approach adopted. SUBMISSION GUIDELINES

Send the abstract of the chapter to the email address husserl@fundacionfilosofica.com with the subject: "Abstract of book chapter". Important dates are in the next section. The abstract should not exceed 250 words without the bibliography. It should clearly describe the purpose of the chapter, area of contribution, research question, hypothesis (if applicable), methodology (if applicable) and the initial plan of the theoretical and empirical parts.

IMPORTANT DATES

Start of abstract submissions: June 15th, 2023

Abstract submission deadline: July 31st, 2023

Notification of selected proposals: by August 31st, 2023



Deadline for submission of finished chapter: January 31st, 2024

GUIDELES FOR ACCEPTED CHAPTERS

The chapters must follow the following guidelines:

- The chapter must have only one main title, without subtitles.
- The author(s) must identify their current academic or institutional affiliation as footnotes, including the biographical summary of each author(s).
- The first draft must include an abstract in Spanish and English, with a maximum length of 250 words.
- Manuscripts should not exceed 9500 words, excluding references, and a minimum of 6500 words.
- The draft and the final version must be sent as a World Document (.doc or .docx).
- Font: Times New Roman, 12 pt.
- Spacing: Text double spaced and aligned to the left, except in tables and figures. Two spaces after the end period of a sentence.
- Margins: 2.54 cm on the entire page.
- Indentation: five spaces on the first line of each paragraph.
- Tables without lines separating cells.
- Footnotes must be Times New Roman font, 10 pt, single spaced.
- Italics will be accepted as font style for words that are in a language different than what the chapter is written in. The use of bold or underlined in symbols, words, tables, or graphics is not allowed.
- Tables and figures will have descriptive titles. All table notes will indicate sources immediately below the table. Column titles will clearly define the data presented. The graphs and tables will be in black and white. Color images will not be received. Send tables and graphs in a separate Excel file that allows the edition of size and font.
- For citations in the body of the text and bibliographic references, only the APA 7.0 standard will be used.

RIGHTS

It is a condition for the chapter's publication that the author(s) cede(s) the reproduction rights to the Central University of Ecuador (UCE) and Filosófica. This must be specified in a cover letter, a form with the author's information and a letter of agreement for the cession of rights. Failure to comply with these rules of collaboration shall constitute grounds for rejection of the chapter.

BIBLIOGRAPHICAL REFERENCES

Citations and bibliographic references will use the American Psychological Association seventh edition (APA 7.0) system.
